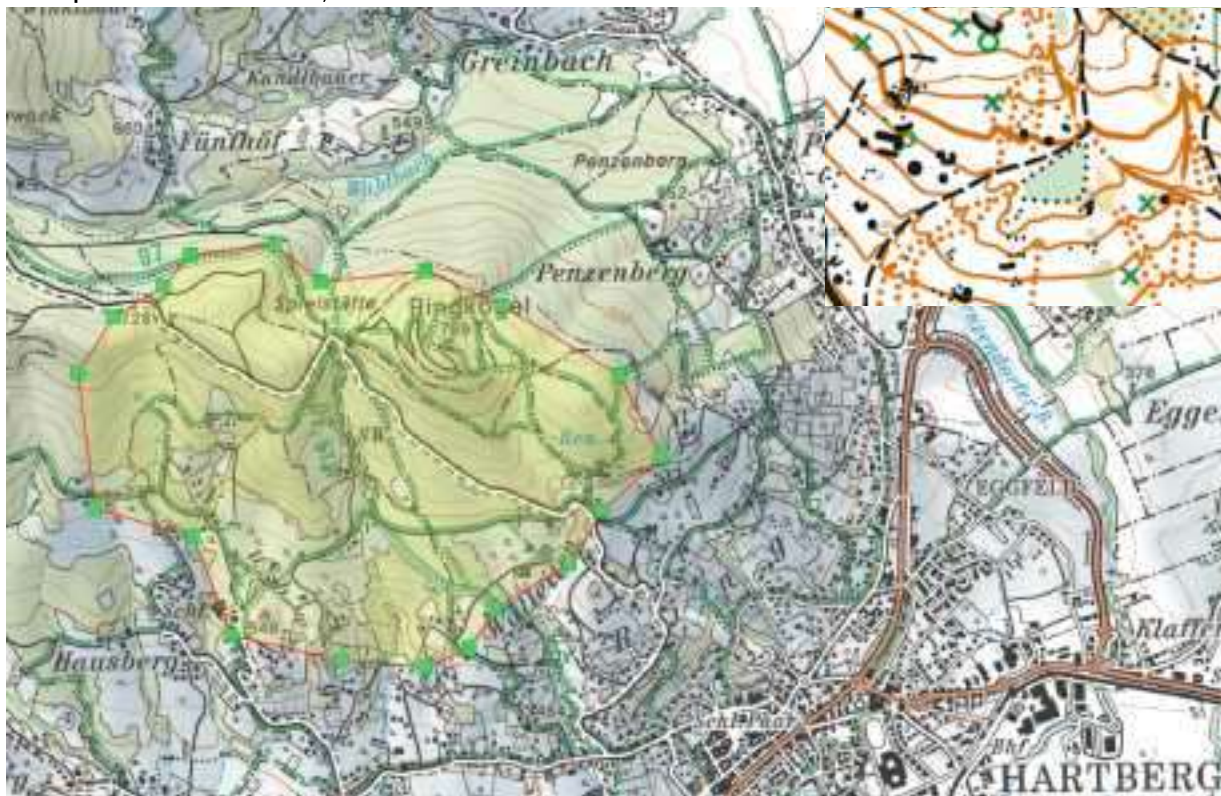

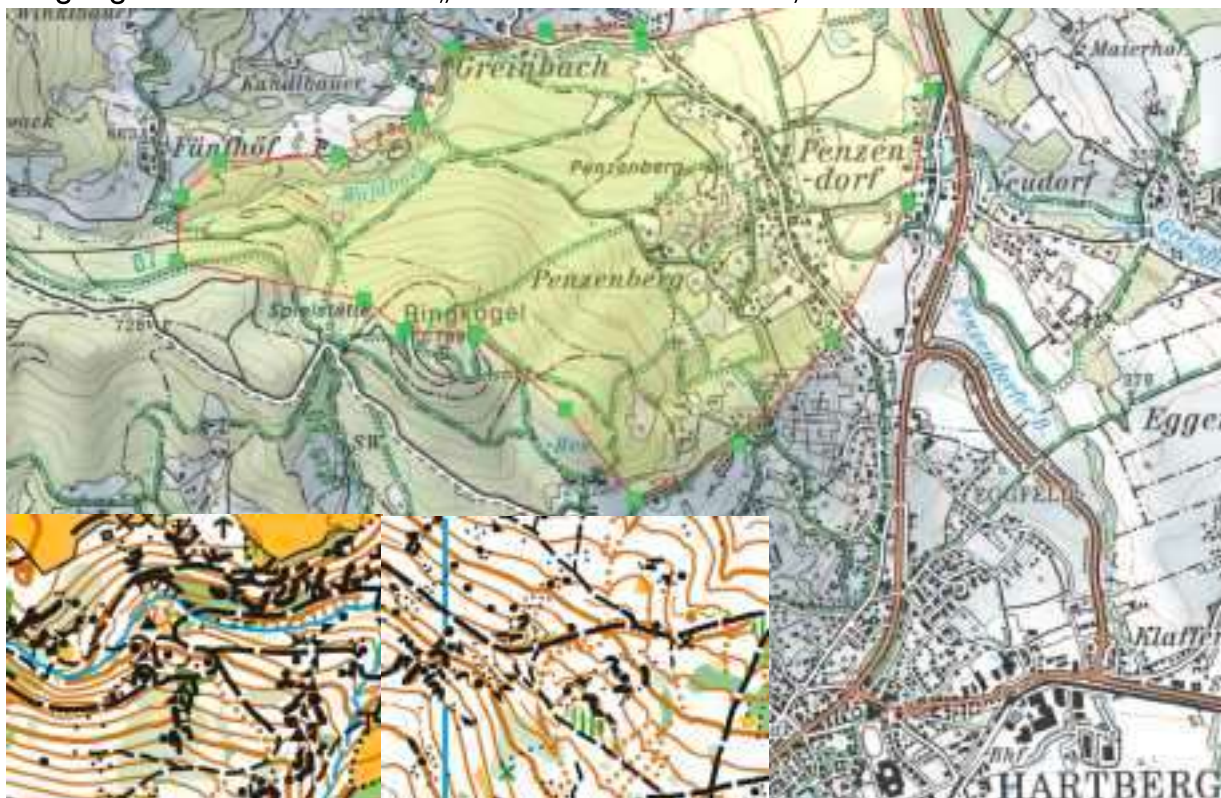

## **General information**

- Sportident Touch Free is used as an electronic punching system.
- SI-Card holders please state the SI-Card number when registering.
- Rental SI-Card: For all those who do not have an SI-Card, there is the possibility to rent an SI-Card (no SIAC) for € 2,- and a deposit of € 30,- at the registration desk.
- The event will be organised according to the valid rules of the ÖFOL competition regulations.
- The organising club accepts no liability for damages of any kind, not even towards third parties. Every runner starts at his/her own risk.
- Training is prohibited in the running area until the competition (moving with a map)
- The provisions of the Road Traffic Act and the Forestry Act must be complied with.
- If the event is cancelled, neither the ÖFOL nor the organising club will accept liability for any costs incurred.
- Participants in the competition agree to the publication of photos taken during the competition and to the publication of the results on the internet.

## **Anti-doping**

By participating, the athlete undertakes to comply with the anti-doping regulations of the Federal Anti-Doping Act 2021 and the relevant regulations of the competent national and international sports federation (in particular statutes, sports regulations, competition regulations). Athletes are defined as persons who are members or licensees of a sports organisation or an associated organisation, or were such at the time of a potential anti-doping rule violation, or who take part in competitions organised by a sports organisation or an associated organisation or supported by federal sports funding. ## **Data protection information**

### Use of data
